RESPONSE OF CERTAIN APPELLEES TO APPELLANTS' MOTION TO REINSTATE APPEAL

In their Motion to Reinstate Appeal, Appellants acknowledge that they filed their briefs late but contend that the late filing was due to "chronic issues with electronic interface between the Windows operating system, certain browsers and the intermittent inability of those browsers to interface with Javascript and similar plug ins, which the most popular browsers are no longer supporting." Mot. ¶ 1-3. Appellants state that they filed their briefs late because Appellants had to find a compatible browser to upload their briefs to the Eleventh Circuit's ECF system. *See id.* ¶ 6.

Appellees note that the Eleventh Circuit's website describes the issue with certain browsers and Javascript that Appellants raise and provides instructions regarding the browsers to use to resolve this issue. The website contains instructions for downloading Java and notes that "[a]ttorney filers can use Internet Explorer 11 and FireFox to file in CM/ECF." The instructions are contained under the "E-Filing Information (CM/ECF)" tab on the home page of the Eleventh Circuit's website. *See* Eleventh Circuit, E-Filing Information (CM/ECF), available at http://www.ca11.uscourts.gov/e-filing-cmecf-information (last visited March 4, 2016).

Appellees believe that the Eleventh Circuit's instructions provide adequate guidance on how to address these issues. Appellees point these items out for the

benefit of the Court, but take no position on Appellants' Motion to Reinstate Appeal. Appellees do request that if Appellants' Motion were to be granted, the Court set a new briefing schedule for the consolidated appeals so that Appellees have at least 30 days to prepare their responding briefs.
