## **PRR Solvent Transition Information**

## When is the last day that I can place my order for 2085b and 1720b with PRR?

PRR customer service will be taking solvent orders until February 29, 2024. Orders placed the last week in February will be delivered the week of March 4, 2024.

## If my business is currently on a solvent delivery cycle, will I still automatically get my service?

All customers who are on an automatic solvent delivery cycle will receive their usual solvent delivery for orders scheduled until February 29, 2024. Automatic solvent delivery orders that are dated for the last week of February will be delivered the week of March 4, 2024.

## How will this change impact my waste services after February 29, 2024?

PRR will continue to provide you with reliable and efficient waste management services. **Starting March 1, 2024, all waste services will be scheduled on a will-call basis.** To place an order for waste services you will need to call our customer service department at (888) 213-1348 or send an email to <u>orders@pacificresourcerecovery.com</u> and request your waste pickup and empty drum delivery services.
